Thank you for confirming Seddon has given verbal approval to bid on the two cloaks and the whalebone mallet at Dunbars on Sunday.

Note that the plus one rule applies for each bid, as set out in the Corporate Governance Manual delegation 12.7.1. (iii):

[The Board] <u>Authorises</u> in respect of items acquired at auction, the Museum's bidder to exceed the authorised indicative price by one final bid, at the increment of the preceding bid, subject to the final bid not exceeding acquisitions delegations, or in the case of a Board-approved acquisition, the upper bidding limit approved by the Board.

What this means is that for Lot 39 if \$100,000 is bid against you, you do not get another bid.

Kiaora koutou in order to ensure robust process the justification for estimates on two cloaks coming up for auction are as follows:

Two cloaks were sold recently in 2006 and 2005 respectively.

In 2006- Webbs sold a Kahu Kiwi for \$110,000.00 Te Ati Awa provenance Te Papa bid unsuccessful

In 2005- Dunbar Sloane, Wellington Kahu kiwi \$100,000.00 Te Papa did not enter auction as we have a large kahu kiwi collection in better condition.

We suggest that the estimate for Kahu Kura or Kahu Käkä is upper limit \$100,000.00 due to feather loss and overall condition in need of clean and some conservation work

We suggest that the estimate for kahu huruhuru with an upper limit bid is \$50,000.00 as we paid recently paid \$40,000.00 for a contemporary, new cloak by Erenora Puketapu Hetet. This cloak at auction requires some conservation work, and has feather loss and areas of deterioration.

## **EXAMINATION OF TWO KAHU HURUHURU**

**Dunbar Sloane Auction Rooms, Mt Eden, Auckland** 

### LOT 39 – KAHU HURUHURU

### General

The cloak is mounted in a closed box frame made from varnished wood with Perspex cover, and it was not possible to examine the reverse of either the frame or the garment. The cloak has been secured within the frame using a Velcro strip, the end of which is visible on the top p.l. edge. The assumed stitching of the Velcro/fabric strip has resulted in a flat, well-supported attachment to the dark gray linen backing fabric. There are no neck ties visible from the front.

The cloak appears to be in good condition apart from extensive loss of feathers due to insect attack.

## Flax components

The kaupapa appears intact, with those areas revealed by feather loss in very good condition with no apparent staining.

The plyed cordage fringing the neck edge is in good condition, but is turned upwards in the area at the p.right closure, as visible in the catalogue photo. This can be relaxed and re-positioned, if necessary.

### **Woollen components**

There are single lengths of red wool overcast stitching down either side of the cloak, which are revealed in areas of feather loss, but otherwise largely obscured by overlapping feathers.

## Feather components

There are large areas of feather loss due to insect attack – these vary from entire feathers missing to vanes completely missing, leaving white rachides visible, to partial grazing of vanes, leaving a ragged, holey appearance. The latter is particularly evident along the bottom edge of the cloak, where the entire line of protruding feathers has been damaged.

A wide band below the neck border has no feathers remaining, and this passes part way down the p.left side. Other large bare patches are visible in the body of the cloak and towards the bottom p.left edge of the garment (see photos).

The white rachides of kaka feathers are very visible throughout, due to loss of vanes.

The area on front, above centre bottom, appears grubby but may result from the gray of the kaka feathers being more visible, following loss of full rusty red effect.

## **LOT 57 – KAHU HURUHURU**

## General

The cloak is displayed high on a wall, hung from polypropylene string loops secured around three nails – one at either top corner, one at centre top. The reverse was examined by climbing up a ladder and holding either half outwards, while looking behind in relatively poor light.

Long flax neck ties hang down from either neck closure.

### Flax components

The kaupapa is in excellent condition, with no apparent losses. From the front, the area under a major area of feather loss (2<sup>nd</sup> full green triangle in middle row, from p.f. edge) has a loosened weave, but all elements are present.

There is a large black felt-tip label inscribed on centre back, below the neck – the words in two lines have been thickly crossed out, making it impossible to decipher.

There is a small patch of what appears to red ochre below centre, near p.left side, just below centre.

### Feather components

There are major areas of feather loss below the neck border and on several of the decorative triangles, as visible in catalogue photo – these all result from insect attack.

### **CONCLUSION**

Both cloaks have kaupapa in good condition with no major losses or staining. Lot 57 will obviously need mounting, if required for vertical display.

The major damage in both cases is feather loss, partial and complete, as a result of insect attack. This may be ongoing, as suggested by evidence of small feather fragments lying inside the frame for Lot 39, ranging from intact kaka feather to white rachides (although these may already have been detached, and simply become dislodged while frame handled and transported).

Photography was difficult due to the position of the fluorescent lighting (Lot 39) and display height (Lot NB:

57)



Note that the plus one rule applies for each bid, as set out in the Corporate Governance Manual delegation 12.7.1. (iii):

[The Board] <u>Authorises</u> in respect of items acquired at auction, the Museum's bidder to exceed the authorised indicative price by one final bid, at the increment of the preceding bid, subject to the final bid not exceeding acquisitions delegations, or in the case of a Board-approved acquisition, the upper bidding limit approved by the Board.

What this means is that for Lot 39 if \$100,000 is bid against you, you do not get another bid.

For lot 57 if \$50,000 is bid against you, you do get one more bid.

Awhina said to me on the phone that her team thought her initial bidding limit suggestions were too high, so presumably she has revised downwards in the proposal to something the team is willing to support.

I am not knowledgeable of this area of the market, and I can't tell from the proposal if the previous sale prices quoted to support the bidding limits are for cloaks that are directly comparable examples. (In general I've noticed the Maori team list previous sale prices (and even estimates) somewhat randomly, without them being directly comparable to the items under discussion.)

These cloaks may merit the bidding limits requested, but the proposal does not articulate that clearly. When the proposal was first submitted, I told Awhina the justification section was too weak and she strengthened it somewhat for the version sent out to CAT, but I think it could still be better argued than it is.

The condition of the cloaks may have been consideration for Dunbar Sloane in setting their estimates; there is quite a bit of feather loss, though the underlying weaving is intact. But it means the cloaks both look a bit threadbare, which might put of some potential buyers if they were wanting purely display pieces.

I am concerned about the amount of money here and would feel more comfortable if the bidding limits were within the catalogue estimates or only slightly above. Even then they are still substantial prices.
