This discussion invites a broad spectrum of experiences, beliefs and opinions from our sector and the communities we serve, this may involve strong minded visitors, protest and demonstration, or activism.

New Zealand's political climate is currently unsettled with single issue extremists, activist organisations and protest groups communicating grievances relating to several issues but notably Palestine, Climate Change, Treaty of Waitangi, and Co-Governance.

This risk assessment is being prepared following significant protest activity that occurred at Te Papa on Monday 11th December 2023, and during which a large group of protesters accessed the museum.

A member of the protest group climbed the English version of the Treaty of Waitangi using abseil equipment and defaced the display using both paint and a power tool. The protest activity was disruptive and resulted in damage to an exhibition item, police responded, and several arrests were made.

The protest group and other parties have made comments which allude to further action being carried out and directed toward Te Papa. Open-source information is being actively monitored, this includes news articles, websites, social media and feedback received by Te Papa.





Kia ora e te iwi,

I wanted to provide feedback related to this afternoons protest activity and confirm actions that are underway.

The protest group carried out a coordinated and well planned action, this involved two separate groups of protestors, one in the entrance foyer and another on level four.

The protest group sought to distract and obstruct responding Security Officers.

A single member of the protest group climbed the treaty display on level four and defaced this display with paint and tools.

Security Officers responded to this quickly (less than two minutes) and attempted to deescalate the situation.

When the safety of our visitors was compromised Police were notified immediately.

Security Officers worked tirelessly to contain the protest activity and were able to successfully move on the vast majority of protestors from the scene within ten minutes.

Security Officers were subjected to some degree of hostility but did not react to this, remaining professional and courteous at all times.

You should be proud of your efforts and acknowledging that situations like this affect everyone differently reach out if you need any support.

We have implemented several actions following this protest activity -

1) Additional Security

A Security Officer will be supplied and positioned in SOAN until further notice.

Mon 12/11/2023 2:37 PM - s 6(d)

On Monday 11th December 2023, at 11:50hrs approximately Security Officer (SO) staffing the main entrance observed a group of approximately 10 - 15 people gathering on the stairs.

The group were observed to open and display a banner which referenced colonisation, exploitation, Treaty of Waitangi and climate.

Senior Security Officer (SSO) s 6(d) has approached the group and asked them to confirm the following -

1) What was the nature of the protest activity?

2) What was the expected duration of the protest activity?

A spokesperson for the group informed **s** 6(d) that the protest was peaceful, that there would be limited impact on the museum and that the protest was not expected to last more than 10 minutes.

s 6(d) has agreed to allow the protest to continue providing that members of the public could safely move from Level 2 to Level 1.

At 11:55hrs approximately **5** (d) was staffing the control room and has received a call from an AV Technician who reported observing a member of the public climbing the English version of the Treaty of Waitangi display within Signs of a Nation.

AV Technician has reported that the member of the public was using a angle grinder and spraypaint to deface the display.

It was confirmed by reviewing CCTV that the member of the public had erected a pole and looped climbing equipment over a lighting fixture before climbing the display.

s 6(d) and s 6(d) have responded and moved to Level 4.

s 6(d) has approached a group of approximately 20 people who were wearing hi-visibility clothing and hard hats. The group had formed a cordon around Signs of a Nation.

has expressed concerns regarding safety but specifically -

1) Paint fumes, being inhaled and/or activating fire detection system within the space.

A member of the group has encouraged **s** 6(d) to move away and stated that the English version of the Treaty of Waitangi could fall.

At this time **s** 6(d) has relayed the instruction to notify Police to the Security Control Room who have contacted Police on 111.

At 12:00hrs approximately Police arrived at Te Papa and moved to Level 4.

Police spoke with <u>s 6(d)</u> and advised <u>s 6(d)</u> that Level 4 should be cleared to ensure the safety of the public.

s 6(d) has at this time informed members the public within Signs of a Nation that they were subject to a Trespass warning and would need to leave the area.

Police have at this time begun to arrest members of the public within Signs of a Nation.

have at this time instructed members of the public within

Level 4 to leave the area.

At 1245hrs approximately Level 4 was confirmed to be clear of members of the public.

At 1300hrs approximately Police had removed all members of the public associated with protest activity.

Summary

The current situation is highly charged and sensitive, requiring a delicate approach to avoid the stated intentions and behaviour of protest groups and their supporters, which is non-threatening towards bystanders and authorities, escalating or being escalated by reactive behaviours by staff or visitors – decisions around the status of the damaged exhibition item are a likely trigger for further activism or protest without an appropriate level of consultation or engagement with interested parties or the community itself.





The group were observed to open and display a banner which referenced colonisation, exploitation, Treaty of Waitangi and climate.

Senior Security Officer (SSO) s 6(d) has approached the group and asked them to confirm the following -

1) What was the nature of the protest activity?

2) What was the expected duration of the protest activity?

A spokesperson for the group informed **s** 6(d) that the protest was peaceful, that there would be limited impact on the museum and that the protest was not expected to last more than 10 minutes.

s 6(d) has agreed to allow the protest to continue providing that members of the public could safely move from Level 2 to Level 1.

At 11:55hrs approximately **5** 6(d) was staffing the control room and has received a call from an AV Technician who reported observing a member of the public climbing the English version of the Treaty of Waitangi display within Signs of a Nation.

AV Technician has reported that the member of the public was using a angle grinder and spraypaint to deface the display.

It was confirmed by reviewing CCTV that the member of the public had erected a pole and looped climbing equipment over a lighting fixture before climbing the display.

and s 6(d) have responded and moved to Level 4.

s 6(d) has approached a group of approximately 20 people who were wearing hi-visibility clothing and hard hats. The group had formed a cordon around Signs of a Nation.

has expressed concerns regarding safety but specifically -

1) Paint fumes, being inhaled and/or activating fire detection system within the space.

A member of the group has encouraged **s** 6(d) to move away and stated that the English version of the Treaty of Waitangi could fall.

E11: Protest and Demonstration

There are three probable types of protest or demonstration that may take place at Te Papa;

- 1. External protests such as, picketing, or obstruction of entrances.
- 2. Internal protests such as, picketing, or obstruction of facilities and thoroughfares.
- 3. Damage, alteration or removal of exhibition, or collection items.

Officers should be careful to maintain a quiet and calm demeanour when dealing with protestors in this circumstance. Avoid confrontation.

If violence, wilful damage or threats against people, property or collections occurs during a demonstration, police should be notified immediately.

Introduction

Te Papa is no longer solely focused on collection, conservation and research, Te Papa is a cultural hub which generates and serves as a platform for open and safe discussion.

This discussion invites a broad spectrum of experiences, beliefs and opinions from our sector and the communities we serve, this may involve strong minded visitors, protest and demonstration, or activism.

New Zealand's political climate is currently unsettled with single issue extremists, activist organisations and protest groups communicating grievances relating to several issues but notably Palestine, Climate Change, Treaty of Waitangi, and Co-Governance.

This risk assessment is being prepared following significant protest activity that occurred at Te Papa on Monday 11th December 2023, and during which a large group of protesters accessed the museum.

A member of the protest group climbed the English version of the Treaty of Waitangi using abseil equipment and defaced the display using both paint and a power tool. The protest activity was disruptive and resulted in damage to an exhibition item, police responded, and several arrests were made.

The protest group and other parties have made comments which allude to further action being carried out and directed toward Te Papa. Open-source information is being actively monitored, this includes news articles, websites, social media and feedback received by Te Papa.


Several individuals, and groups have made comments on social media reacting to protest activity and alluding to counter-protest or activism being directed toward Te Papa and some comments have threatened to disrupt and damage taonga these individuals and groups appear to be connected to alt-right movements.




Te Papa get that English Version of the Treaty cleaned up or replaced or face the wrath of the people and many are now threatening to deface Maori artefacts.

Weekly Intelligence Report

Incidents

On Monday 11th December, Te Papa was targeted for a rehearsed attack by activists who initiated a protest on level 1 while simultaneously vandalising an exhibition on Level 4. Front of house staff responded quickly and appropriately to this incident by minimising harm. Protest activity resulted in 12 arrests, 18 trespasses, and significant damage to the Te Tiriti exhibition. This has drawn media attention internationally.

There has been an increase in activity around the Tiriti exhibition as a result of the damage. Several individuals have behaved in a suspicious or disorderly manner and incidents have been deescalated by security through a customer-focused approach. This is expected to continue.

Notes with bank account details appealing to visitors for donations to assist the arrested activists were found on Level 4 and have been reported to police.

On Thursday 14th December, a suspicious person was witnessed inspecting an abandoned bicycle in the contractors car park and monitored by security via CCTV.

Risk Assessments

A general Protest and Demonstration risk assessment was completed on Tuesday morning. This has been approved by ELT and communicated with Security and Visitor Services Managers.

A previous risk assessment has been communicated to the team in relation to the Dinosaurs of Patagonia exhibition which opens this weekend.

Matters of the Moment

Te Papa remains a potential target for activism and protest activity. Several groups including Aotearoa Liberation League, Te Waka Hourua, and Stop Co-Governance have put out call to actions to their members and followers to contact Te Papa enquiries with various messages. Social media is being monitored for potential risks and threats.

The team is encouraged to familiarise themselves with personnel who have been trespassed so that police can be notified if they return to site. Security will wear hi-visibility vests Front of House and an additional security guard will be positioned on Level 4. We maintain our core focus points.

Additional protest activity related to the conflict between Israel and Palestine continues in the Wellington region. General awareness and vigilance is recommended.

Threat Level

On Monday, our threat level moved temporarily to **Exceptional** in response to the attack. Our current threat level is <u>Heightened</u>.
