

Post protest planning and summer preparedness

This hui was called by Co-Leaders to make timely decisions about the damaged Signs of the Nation exhibition panel and gain assurance Te Papa and kaimahi are prepared for the summer period.



Recommendation: That the damaged English language panels in the Signs of a Nation exhibition be removed and stored


Reasoning for recommendation:

- We have accepted the protest action in good faith and not "covered it up"
- The defaced panels are not a designed experience for our visitors such as we would normally
 provide. This makes it hard for our FOH kaimahi to manage and support questions. We have safety
 and wellbeing concerns for our kaimahi over the busy summer period should the panels not be
 removed
- Security monitoring shows the risk of retaliatory actions (e.g. damage to other parts of the exhibition, taonga Māori) that we believe will be exacerbated by the extended presence of the defaced panels.

Counterpoint: removal of the panels may provoke either further action by the original protest group or by others. This risk must be noted against the above concerns, which are felt to be more pressing.

Decision: Agreement obtained to deinstall and store the damaged panels in Signs of the Nation exhibition.

DISPLAY DETAILS

- Consisting of 4 x wooden panels (referred to 'artwork' in this document for ease of reference).
- Each artwork panel measuring approximately: 1490 x 4200 x 105 mm (h x w x d)
- Approximate total dimensions: 5960 x 4200 x 105 mm (h x w x d)

HANGING FIXINGS: [Only sighted while in situ]

- On the back of each panel there are 6 fixing points 3 top and 3 bottom.
- There appear to be 6 fixings for each artwork panel. The fixing is a metal L plate one attached to the wall, and a corresponding one attached to the back of the artwork.
- The wall L-plate aligns with the L-plate on the back of the artwork panel, and an approximate 12mm bolt goes through the two corresponding plates to hold the artwork panel to the wall.
- Apart from the three top fixings for the Top artwork panel (which only has a bolt holding them together),
 the other plates appear to have a pin welded to the artwork L-plate, as well as the bolt.




Image of Top Panel – one of the 3 fixings along the top of the artwork panel.



LS noted progress on updating IMT roster over summer, requested CRT to ensure her team have updated.

CJ noted that the risk profile around Signs of a Nation and our actions in relation to this space have shifted considerably since the end of last week.

- At the end of last week, we had concerns about retaliatory actions (e.g. damage to the reo Māori panels) or protests against the original protest action
- Over the weekend and with the announcement on Monday from Te Waka Hourua, this has shifted to significant concerns about ongoing protest action from the original groups and others who may ally themselves to the cause, especially given the use of social media to share planned activities

(compared to mainstream media, which has been relatively quiet). This is deemed as a more significant risk now.

- Removal of the panels at this time is likely to create more risk of further action and thus pressure on FOH kaimahi and our Security team over the summer period
- We have further assessed the safe removal of the defaced panels. Advice from the PMO is that more time is required to plan and implement the removal, following all our normal project procedures, having a good understanding of what's needed to make good following the deinstallation
- Meetings with Ngā Whetu Ririki and conversations with kaimahi indicate the strength of sentiment around keeping the panels in place and allowing the korero happening in the exhibition space to continue and be fostered with planned activities in 2024

Recommendation: That ELT confirm the Co-Leaders decision, based on advice from IMT, that the panels stay in place over the summer period.

This recommendation is brought to ELT noting the Friday 15 December special meeting where the decision as made, on information available at that time, to proceed with deinstalling the panels. We note that the IMT will be making necessary decisions for the management of risk and response to the planned follow-up action on the 20th.

I am looking forward to our meeting this Wednesday. I am writing in regard to a specific matter, the decision to leave the damaged panel of the Treaty of Waitangi | Signs of a Nation exhibition in place while decisions on a replacement or renewal of the exhibition are undertaken.

As responsible Minister, I appreciate the role and responsibilities of the Board under its enabling legislation and other key legislation including the Crown Entities Act 2004. However, I would like to express my strong view that the damaged panel should be removed or repaired as soon as possible.

In my opinion leaving the panel in its damaged state is inconsistent with the Board endeavouring to ensure that the Museum is a source of pride for all New Zealanders (section 8(c) of your Act). I consider that the damage to the panel denigrates our nation's founding documents and national identity.

I understand the process to replace the Signs of a Nation exhibition was intended to begin in 2020. I have asked my officials to follow up progress in this area.

I look forward to discussing my views with you at our meeting this week.



Kia ora Out

Firstly, I'd like acknowledge the work oid at the end of last year associated with the potential dismantling of one of the exhibition displays here at Te Papa.

This project is now set to come back online, with the change that both sets of display panels are to be removed. This is early days in the project's re-ignition, but I have been asked to start investigating when and how the panels could come down.

In the first instance I'd like to know if would be interested in considering this job again, and if possible, whether we could get a rough ballpark on costs for this work.

There is a change to the plan, where now we will be looking to deinstall both displays – the English and the te reo panels. I've not yet looked behind the te reo panels, but will look to do that in next few days to confirm the fits are similar to those sighted behind the English panels.

You'll I've noted I've not mentioned dates, I'm loathe to do so when there are still some internal elements still to be confirmed. I know the desire is to get the panels down as soon as possible, but also for the empty cavities behind the panels to be covered/concealed or something projected. So until I know more I don't feel comfortable pushing ahead with trying to get a time period booked in, and then have it fall over again.

This is all assuming Out are still amenable to being involved.

I recall from last time we had questions about insurance — and whether Te Papa's public liability (if we have it) would cover this work, or whether we would be asking to have it. I'll continue to resolve these elements and get back to you on in.

Purpose

- The purpose of this report is to provide you with updates on key progress regarding the *Signs of a Nation* renewal programme.
- Officials are available to brief you further at your request.

Introduction

Te Papa has committed to renewing the whole of the Signs of a Nation exhibition.

On 19 December Te Papa issued a media release advising that the damaged panel would remain on display over the summer break, after which it would be removed for storage and to prepare the space for renewal. The first step is the deinstallation of the damaged panel and the creation of a temporary audience experience, while the new long-term exhibition is planned, designed, and installed.

It is likely to be at least two years before the whole exhibition is renewed. Prior to final decisions on design and content it will be the subject of consultation with the public, iwi and interested groups. We note your letter of 26 February to the Te Papa Board Chair.

Our current focus is identifying and managing all of the relevant components of the work to remove the panels and create a temporary experience and allocating resource to this.

Progress

The panels are large objects in a highly utilised space. They were installed when the museum first opened and de-installation will be a significant piece of work. Their removal is a complex piece of work requiring external equipment and contractors.

We have initiated the project to remove the panels, including the health and safety plan, securing external equipment and contractors, and managing the wider museum visitor operation during the period of work.

Exhibition staff are concurrently working on the temporary use of the space until the new permanent exhibition is created.

As is our standard procedure at Te Papa, we have notified Mana Whenua of the work programme and intention to commence deinstallation. They have indicated they support our whakaaro and will support us when we take down the panels.

Next planned deliverables

Current project deliverables:

- Finalise the engineering assessment
- Finalise the health and safety plan
- Contract external equipment and contractors
- Engage with mana whenua on tikanga for closure
- Storage planning
- Internal and external communications and media management
- Confirm closure and deinstallation date pending logistics noted above.

We anticipate completing all this work by 22 March and plan to provide the date of closure and deinstallation in our update next week.

Risk Management

<u>Collection care of taonga</u> on display in the *Signs of a Nation* exhibition is a priority and will require assessment and consultation with relevant stakeholders prior to moving into storage. This programme will inform any resourcing pressures or flow on effects that it will have on other exhibition planning and delivery outcomes.

Ongoing public interest and potential for further protest action. We anticipate continued interest in the development of the exhibition space. We will need to manage diverse public views, within a public space across the period of new exhibition development, and at the time of its installation and reopening. We do not anticipate making a public statement about the closure until a date for deinstallation is confirmed, but if we receive any media enquiries, we will respond noting that plans to close the area are being progressed.

Under the "no surprises" approach, we will continue to keep your office informed of any intended communications to be shared either with media or more broadly to the public by press release or by Official Information Act response.





MEDIA QUERY - Out OIA

Te Papa announced in December that the spraypainted panel would remain in place over the summer break and then be removed and stored.

The logistical planning for this is underway – there are challenges in doing construction work in a facility that is open to the public seven days a week. We don't have a date yet for the removal.

Te Papa is an open, accessible space that welcomes over a million people a year, we are always focussed on the balance between that openness, and the need for security. It's not the role of Te

Papa security to physically intervene with members of the public – staff followed the appropriate course of action, which is to call Police.

Te Papa has formed a team to create a new exhibition on Te Tiriti o Waitangi. That team is planning how to renew this space, including how long this might take and community engagement. It is a complex and important topic and the redevelopment will be done in a thoughtful, inclusive way – that will take time.

As for many organisations, the last few years have been a very disrupted period for Te Papa as we adapted to a series of major changes due to covid. We had expected to begin work on this exhibition space earlier, but that didn't occur.





Overall observations:

- Ratio of approval/disapproval: Out of scope , the comments start as mostly disapproving of the protestors actions and call for Te Papa to restore the English version of the Treaty (roughly the first 30 comments). However, this overwhelmingly changes as time passes, and by the end of the comments I'd estimate that a vast majority of comments are in support of the protestors and call on Te Papa to make changes with the protestors actions in mind/collaborate with Iwi.
- Whilst the coming comments in this document more so reflect the comments that support the actions of the protestors, this is reflected in the overwhelming statistic of comments that support this compared to those that do not.
- 410/509 comments indicated their support for the protestors while 33/509 comments indicated they disapproved of the protestors. The remaining 65 comments were either ambiguous on whether they supported/didn't support the protestors (some comments weren't clear on this however were clear on whether they thought the exhibit should remain or not). Please note the bottom of the excel spreadsheet where you can see how many of each code there is.

Main themes

Comments supporting the protestors/change of the exhibit

The presentation of the Treaty exhibit misleads the public

- Due to the way the two large signs stand side by side, without prior knowledge one might assume the Te Tiriti o Waitangi is a direct translation of the treaty. "Choosing to allow the two Treaties to sit in this way is a conscious decision to misrepresent Te Tiriti."
- There is a history of misunderstanding of New Zealand's treaty and the differences between the Treaty and Te Tiriti, the presentation of the exhibit adds to this misunderstanding and therefore, Te Papa should act to combat this misunderstanding.

 Some comments refer to the colonial/genocidal harm/systemic racism in NZ and how a misleading exhibit continues this harm. Comment 104,150 are some clear examples of this.

Many comments call on Te Papa to drop the charges made against the protestors. Comment 40 is a clear example of this. Under the code "I approve of/support the protestors actions and intent" a majority of these comments refer to dropping the charges against protestors.

The changes protestors made to the Treaty exhibit are prompting important conversations, more so than the exhibit did before and therefore, the exhibit should remain with these changes. A few comments refer to people learning a lot more about the Treaty because of the protest, more so than they ever did in school/formal education. Comment 222,332 is an example of this kind of comment.

Comments 108/109 are examples of a theme of comments that refer to Te Papas obligation to provide accurate accounts of history and how their display of 'Hobson's draft' has failed to do this.

Many comments refer to commenters disappointment and shock to learn that Te Papa has not followed the advice of Māori leaders and experts. Comment 203 is an example of this.

Many comments ask for the exhibit to stay as it is until proper consultation has happened with Iwi and Māori leaders. In these cases, I've coded these comments under "keeping" the exhibit and also "changing" the exhibit.

Comments against the protestors actions/changing the exhibit

- The protestors are criminals and Te Papa should not support vandalism by "folding like wet cardboard and give them what they want". A few comments call the protestors extreme words such as "savages" or "vandals". These characterisations take place in comments that condemn the actions of protestors.
- There are a few comments that claim Te Papa is racist for supporting the "racist" protestors, an attempt to remove the English version of the Treaty insinuates an erasure of European history.
- Some comments suggest that Te Papa shouldn't engage with a small but vocal minority group and that their views do not represent the views of the majority of New Zealanders.
- A few comments suggest that the defacing of the English Treaty opens the doors for people to deface other exhibits as they please.

Highlighted comments

- Comment 4: Condemns the vandalism of the Treaty exhibit and asks that the exhibit is restored so "this essential part of our mostly peaceful history is remembered".
- Comment 5: A really interesting example of how the Treaty exhibit misled someone as a child, and how they've been reflecting on that as an adult. This comment reflects the widespread misunderstanding of our country's Treaty
- Comment 6: This commenter says Te Papa has failed to do its job by not protecting its national treasures.

Comment 23:

- Comment 32: From public figure and former politician Don Brash. (Whilst I don't believe that someone's comment is more relevant based on their status, Brash's comment is substantial in volume and based on his words is reflective of a wider community. Therefore, I deemed it valid to be highlighted as an example of a comment that is against the protestors actions.
- Comment 70: This is a comment that likely was curated on social media, and asked to be shared to Te Papa in support of the protestors and calling for the new "artwork" to remain. Therefore, there are many comments that are the same as this one, as multiple people copied and shared this.
- Comment 74: Highlights Te Papas history of displaying and promoting protest movements and calls for Te Papa to not fall into hypocrisies in regards to this protest.
- Comment 76: I'm unsure of whether this is accurate. However, they claim that "the comfy couches [were] facing the English draft". Whilst this may be interpreted as a minor comment in the scheme of things, It is interesting to note that if true, this could be a subconscious framing on Te Papas behalf of intentions behind the exhibit.
- Comment 101: An example of a comment that refers to Te Papas obligation to recording historical accuracies and how the display of Hobson's draft is a failure to do so. There are many comments aligned with this one.
- Comment 179: An example of a comment that refers to the crowns obligation to honour Te Tiriti and Te Papas place as a treaty partner.
- Comment 212: A comment from an overseas visitor who viewed the exhibit not knowing that this was the work of a protestor. Interesting/unique comments and reflections.
- Comment 300: This comment encompasses many of the previous comments that calls on Te
 Papa to take action in changing the Treaty exhibit. I'm highlighting this comment as it
 summarises many of the previous comments in the documents and is a good example of
 many peoples thoughts collated in one.
- Comment 421: CONCERNING COMMENT REGARDING TOUR GUIDE unsure whether is a Te Papa staff member. However, if so, his comments referring to pre-colonial New Zealand as prehistoric and his communication of this to visitors is CONCERNING. Please look into this ASAP and refer to his full comment.
- Comment 424: A comment that attempts to liken Te Papas engagement with Te Tiriti experts as the same as supporting Hitler and Mussolini and their positive traits such as pioneering technology and unifying people. To engage with Te Tiriti experts is the same as platforming Hitler is essentially what this comment is referring to

We are on track to provide the date of closure and deinstallation in our update next week.

With external partners' confirmation of dates, we will focus on due diligence and procurement of services and preparing our staff for this change.

Future programme - Signs of a Nation space

Our current focus is managing all of the relevant components of the work to remove the damaged panel and create a temporary audience experience. As this is the first stage of renewing the full *Signs of a Nation* exhibition, we are concurrently considering what a 12 -18 month (rather than two year) full renewal plan needs to include - this will be influenced by the extent of community engagement we undertake.

For comparison, previous renewals of permanent exhibition spaces have taken between 18 months and three years to complete, with project costs ranging between \$8 - \$12 million.

It is important to note that trade-offs between significant programmes of work have led to delays with progressing earlier planned exhibition redevelopment on *Signs of a Nation* and the surrounding spaces on level 4 of Te Papa. Since 2015 we have had to prioritise deferred maintenance on the building, with major infrastructure replacement projects including heating, ventilation and air conditioning (HVAC) system upgrades, exterior cladding and joint sealing, lift upgrades, seismic strengthening and replacement of water chillers and water-cooling towers, plus building system management upgrade. Infrastructure management work will need to continue and be balanced within a constrained fiscal environment, alongside the renewal of *Signs of a Nation*, to maintain an appropriate and safe environment for storage of the national collections and hosting hundreds of thousands of visitors.

No decisions have been made as to whether Te Papa will keep the panel in the long term. However, we have been monitoring feedback from the public on *Signs of a Nation* and note the very diverse perspectives and reflections that have been made in response to having the panel on display. As a collecting institution partially responsible for the memory of the nation, Te Papa is mindful of the role protest action has within New Zealand's social history. Until a decision is made as to whether the panel will or will not be formally taken into the collection it will be stored at our signal () Upper Hutt building.

Risk Management

<u>Collection care of taonga</u> on display in the *Signs of a Nation* exhibition is a priority and will require assessment and consultation with relevant stakeholders prior to moving into storage. This programme will inform any resourcing pressures or flow on effects that it will have on other exhibition planning and delivery outcomes.

Ongoing public interest and potential for further protest action. We anticipate continued interest in the development of the exhibition space. We will need to manage diverse public views, within a

public space across the period of new exhibition development, and at the time of its installation and reopening. We do not anticipate making a public statement about the closure until a date for deinstallation is confirmed, but if we receive any media enquiries, we will respond noting that plans to close the area are being progressed.

On 14 March we received a letter from Te Waka Hourua enquiring about further progress on *Signs of a Nation*. We have not responded but note they have also released a social media post encouraging members of the public to contact Te Papa. We are not intending to make any public comment or response at this stage.

Under the "no surprises" approach, we will continue to keep your office informed of any intended communications to be shared either with media or more broadly to the public by press release or by Official Information Act response.





In October 2021, protest action occurred about the content of the exhibition particularly the display of Te Tiriti o Waitangi and Hobson's draft of the Treaty of Waitangi as misleading translations rather than different documents. In December 2023, a group named Te Waka Hourua redacted Hobson's draft with black spray paint in further protest action.

Te Papa announced in December 2023 that the exhibition will be refreshed working meaningfully with iwi Māori.



In order to meet the commitments outlined in the paper and to honour the enduring and meaningful relationships with Mana Whenua it is recommended that initial engagement take place with Mana Whenua to provide leadership and guidance with regard to:

1. the deinstallation of the redacted panel (including tikanga and dates);







I wanted to reach out and keep you in the loop about activity set to occur at Te Papa next month and which relates to the exhibition that was damaged by activists on Monday 11th December 2023. Te Papa has decided to deinstall the damaged panel as part of renewal project which includes the Signs of a Nation exhibit it is probable that the deinstallation will occur on Monday 22nd April 2024 after the museum has closed (18:00hrs).

Once the panel has been deinstalled a temporary exhibit or feature will be installed in its place and the long-term goals of the renewal project can be achieved. The damaged panel will be moved into temporary storage at Te Papa before being moved to permanent storage at Se(2)(c) Upper Hutt.

Te Papa is in consultation with both experts and Mana Whenua about both the immediate actions being carried out and the renewal project generally. Te Papa has decided to provide a media statement the week before deinstallation it has been suggested that this may reduce speculation and possible reactionary activity.

We have put together a preliminary Security operation to coincide with this stage of the renewal project and I have attached for your reference a copy of our initial risk assessment and preliminary operations briefing, key take aways are —

Te Papa is applying significant caution to how information is shared relating to this stage of the renewal project as there are indications that a leak(s) may have occurred and there is a screenshot of a social media post published by Aotearoa Liberation League within the attached risk assessment which alleges that the source of leaked information was Te Papa Staff.

At this stage, I am not aware of any direct threat or risks to Te Papa but it is a real possibility that the deinstallation of the damaged panel may provoke reactionary activity by Te Waka Hourua or individuals who are either sympathetic to or oppose the activism carried out by Te Waka Hourua.

We continue to work with mana whenua to prepare for the deinstallation of the defaced panel and will be engaging with them on the development of the temporary experience. Their availability and any impact on preferred timelines will be monitored and negotiated on an ongoing basis.







Progress update since last report

No significant operational progress or concern to report this week.

This week we have prepared our public communications and engagement activity that will support this change.

Our current plans for public communications include:

- A media advisory notice to key journalists and a post on Te Papa social media (planned for approx. 17 April – to be confirmed).
 - This is intended as a "heads up" to the public that we will be changing the area of the Signs of a Nation exhibition that was damaged during protest event in December 2023. Some important notes:
 - It is intended to be proactive as to manage and mitigate the continuous flow of enquiries we've been receiving.
 - We intend to share which week the exhibition will updated in (22 26 April),
 however will not be sharing the actual date for health, safety, and security reasons.
 - This will be supported by a plan for managing media enquiries, social media, and public enquiries across all our channels.
- A proactive press release to be issued on morning of Tuesday 23 April with our Co-Leaders available for comment. If the deinstall and install doesn't experience any unplanned incidents this press release will occur concurrent to opening to the public.

Our overall goal with communications is to de-escalate any sense of drama or surprise around this event, to minimise the risk of a reaction that disrupts the museum.

Risk Management

<u>Exhibition change.</u> As these panels are part of an establishment exhibition (installed in 1998) there are several unknowns that may be realised once the panels are removed or installing our updated experience occurs. If anything arises, we have experts on hold to manage at the time. However if something major is identified there is a risk, we may need to close the area for any given period of time. We have contingency plans in place should this occur.

<u>Partnership with key stakeholders</u>. We continue to work with mana whenua to prepare for the deinstallation of the defaced panel and will be engaging with them on the development of the temporary experience. Their availability and any impact on preferred timelines will be monitored and negotiated on an ongoing basis.

Ongoing public interest and potential for further protest action. We anticipate continued interest in the development of the exhibition space. We will need to manage diverse public views, within a public space across the period of new exhibition development, and at the time of its installation and reopening. We do not anticipate making a public statement about the closure until a date for deinstallation is confirmed, but if we receive any media enquiries, we will respond noting that plans to close the area are being progressed.

Under the "no surprises" approach, we will continue to keep your office informed of any intended communications to be shared either with media or more broadly to the public by press release or by Official Information Act response.

Kia ora Te Papa!

I'm writing as a Tangata Tiriti parent to express my deep concern for a healthy functioning democracy (relying on ACCURATE understanding of our coloniser state history) being eroded by Minister Paul Goldsmiths unlawful pressuring of your management to remove the redacted and Tiriti exhibits without specifying in proper transparency and accountability, what will replace them.

I live in § 9(2) and treasure Te Papa .Visits there are a highlight whenever we are visiting Poneke.

So It's an outrage, given we know Te Tiriti is under direct attack by the umbrella organisation the Atlas Network because it impedes their aim of unfettered exploitation of both workers and fossil fuel deposits here in Aotearoa, that the redacted draft English Treaty panel is being removed along with the Te Tiriti o Waitangi panel after media have exposed the fact that Minister Goldsmith has no legal right to interfere with your curatorial decision and is known to be part of a minority elected government that has demonstrated its willingness to come to power in the back of racist disinformation about Maori and in Act and Nz first's case , racist disinformation about Te Tiriti.

It's even more outrageous that Te Papa's decision makers appear to have capitulated to this brazen ministerial overreach.(especially in the context all the other measures this govt has eroded our democracy to push through measures that do not have social licence from us, the public, under misused urgency.)

I've been to Te Papa with my teen specifically to see this exhibit, and I interact all too regularly with disinformed Pakeha Tangata Tiriti whose weaponised ignorance and fear is fed by the racist mythtake (quoting s 9(2)(a) here, who your curatorial advisory body chose to ignore) that Maori rangatira willingly ceded sovereignty. As you welll

know, there is no historical precedent for any indigenous group ,world wide ,ever doing this willingly . Our democracy is fragile and we cannot afford this deliberate obscuring of the deliberate political choices made to obscure our historical facts.

Especially ,in the age of coordinated disinformation by the likes of the Atlas funded organisations like astroturf Taxpayer's Union and the NZCPR who put out an extremely well funded mailout miscontectialising Kaumatua Apirana Ngata (https://thespinoff.co.nz/atea/05-02-2024/according-to-apirana-ngata-maori-ceded-sovereignty-by-signing-te-tiriti-is-he-right)

Because of the way that Te Papa staged this exhibition, most New Zealanders would not know that the English text presented on equal terms with Te Tiriti in your display is a mere draft (Hobson's wishlist), and the actual Te Tiriti o Waitangi is what the vast majority of Maori chiefs actually signed. Even fewer people know that Te Papa had been asked to change the exhibit for years (by many including signed) in order to make it accurate, and that this request had been ignored by your management. To display the English draft and the actual Maori Tiriti as equals, when international law says the text signed in the indigenous language will always stand if there is any confusion over multiple texts) is deliberate and hugely divisive act.

To place them in such a way as to imply that the current English text is even a translation of Te Tiriti, is another direct obscuring of the truth.

The history of these curatorial choices is cumulatively so harmful to Tangata whenua path to Tiriti justice and Tangata Tiriti understanding (at a time of deliberate weaponising of hatespeech and racist misinformation) alike that it's history must be kept transparently available until the correct, tangata whenua Tiriti expert approved exhibit is in place.

I demand transparency in regards to what Te Papa is temporarily putting in the place of this.

Te Papa has not publicly shared what is planned for the development and replacement of the exhibition or who is involved in that process.

Te Papa is being forced by the Minister of Culture and Heritage Paul Goldsmith to remove the redacted panel, without any proper process to determine what will replace it - this is immoral and also illegal because as covered widely in our media including RNZ, Paul Goldsmith has no lawful right to influence Te Papa's curatorial decisions.

I expect transparent public processes about this critically important exhibition discussing our founding constitutional documents.

Te Tiriti justice must be the centre of that process!

Te Papa's mistelling of our foundational stories for almost three decades was able to happen because of the same Crown-centric bureaucratic processes that you are falling back on now.

We want better. We can do better. We want Te Papa to tell the truth!

We have contingency plans in place should this occur.

<u>Partnership with key stakeholders</u>. We continue to work with mana whenua to prepare for the deinstallation of the defaced panel and have engaged with them on the development of the temporary experience. Their availability and any impact on preferred timelines will be monitored and negotiated on an ongoing basis.

Ongoing public interest and potential for further protest action. We anticipate continued interest in the development of the exhibition space. We will need to manage diverse public views within a public space. Our approach is to de-escalate risk and hence while the change date remains strictly confidential, on 18 April notification was made that change will take place in the week beginning 22 April. Active media engagement is not anticipated until the change is completed.

Under the "no surprises" approach, we will continue to keep your office informed of any intended communications to be shared either with media or more broadly to the public by press release or by Official Information Act response.

A heads up for you.

I activated IMT last night to manage our response to planned protest action. That incident has now passed. Ordinarily, I would argue we stand down at the end of today. We are not here to manage the SOAN project risk.

The key risk today in relation to protest is a sit-in just before closing. We are closing the building early (5.50pm) and we have asked mana whenua to come to TTP entrance at 6.10pm. Once we are happy the building is secured for the evening the job is done for today.

From what was said by TWH today we do not believe they have plans to return immediately. Their key interest is in Te Papa engaging with them on what is put into that space. That could change when they learn that the exhibit has been changed overnight, but unlikely. They did talk today about coming back in a month.

The media speculation about the work happening tonight though could raise interest from counter groups - those who oppose taking down the defaced panel.

I will advise IMT at our meeting at 5.30pm that unless anything changes, we will meet again at 2pm tomorrow, and all going well, stand down.

The SOAN project had already developed a range of scenarios for what could happen in the lead up to and after the temporary exhibition is in place, and how to manage that from a security perspective. It is inappropriate to have IMT managing project risk.

A protest at **Te Papa** over the impending removal of the vandalised Treaty of Waitangi **exhibition** charges. The group behind this morning's action, which saw someone scale the treaty panel and take to it with spray paint, is calling for police to withdraw charges against those involved. Te WACA spokesperson Carly O'Neil says they shouldn't be punished for correcting an historic inaccuracy.

The very least that's Papa can do is urge the police to drop charges because those two people are just being made examples

This week removed the exhibit, which protesters spray painted last year. The group behind the damage to Waco gathered outside Te Papa this morning, and group organiser Kelly O'Neill says the museum needs to be up front about what will go in its place.

We're here both to celebrate the fact that we achieved what we set out to achieve and also to continue holding Tapapa to account because we currently don't have any information about what they are planning to do with that.
