Re: Official Information Act (OIA) Request - unaccompanied material or items

I refer to your OIA request of 11 April 2025 for:

Since January 1 2020, copies of all reports, briefings, documents and emails relating to any incidents when material or items were mistakenly left unaccompanied in public.

Thank you also for your email on 14 April 2025 in which you confirmed you were asking about material being left in public spaces and that you were 'intending to capture the sort of thing where an item, documents etc may be left mistakenly in public i.e. a cafe or restaurant'.

We have identified seven instances between 1 January 2020 and 11 April 2025 in which Te Papa material or items were left unaccompanied in public. The items were: two cell phones, one laptop, two staff access cards, one security uniform, one wheelchair, and one jacket. I attach documents relating to these instances to this letter.

Additionally, we have identified other instances where Te Papa items were lost and therefore potentially left in public. To summarise, there were 20 cell phones, 16 access cards, two access wristbands, and one photo ID card. Access for each lost card/band and phone was disabled. As we have no way of knowing they were in fact left in public, we have excluded the information relating to these instances from this response.




